You must have a current Academy of Model Aeronautics ("AMA") membership (which provides you with insurance), and have a current and valid Federal Aviation Administration ("FAA") registration number for recreational model aircraft before flying at the field.

If the applicant is under 18 years old, this waiver must be completed and signed by a parent or legal guardian.

## REQUEST, RELEASE AND WAIVER OF ALL CLAIMS AGREEMENT

I have been informed of and I know the risks and dangers involved in the operation of radio controlled aircraft, and that unanticipated and unexpected dangers may arise during such activities and I assume all risks of injury to me and my property that may be sustained in connection with the stated activities including, but not limited to, the potential crash and loss of my aircraft and its on-board equipment and personal injury to myself or others.

In consideration of the permission granted to me to participate in the stated activities, I do hereby, remise and discharge PARCS, its board members and volunteer flight instructors in the stated activities of and from all claims, loss, damages, demands, actions, and other causes of action of any sort, for injuries to person and/or property during or as a result of participating in any of the activities contemplated by this Agreement, whether such loss, damage, or injury results from the negligence of PARCS, its officers, board members, volunteer flight instructors or from any other cause.

I represent and certify that I, the applicant, am over 18 years old (or I am a parent or legal guardian of the minor applicant), and that the applicant is a member in good standing of the AMA.

You should be aware and understand that the activities involved in the flying of model airplanes are not without some degree of hazard. Therefore it is the obligation of all PARCS members and their guests to abide by the safety rules of the AMA, PARCS, and those dictated by common sense to minimize these hazards and to assist the PARCS Board in its attempt to provide a safe environment for all members and visitors. The PARCS club, its Board of Directors, individually or collectively, will not be held liable for incidents involving injury or property damage, including, but not limited to, loss of aircraft. By submitting the membership application and signing this Request, Release and Waiver you hereby acknowledge and accept these conditions.

I have read and understand the current PARCS "Safety Rules" and agree to abide by them, as well as those of the AMA and any rules and restrictions of the Federal, State or Local authorities. I also agree to be bound and abide by any future updates, changes or modification to any rules, restrictions or laws.
